- 13. C.O.G. Report Councilman Tim Ward
 - 1) The C.O.G. met on April 27th A guest speaker from Allegheny County Library Association presented, promoting libraries as assets to the community. Asking boroughs to include libraries on website.
 - 2) A big topic of discussion was asbestos abatement for demolitions. This will increase costs by approximately \$10,000 per unit.

 - 1) There was a water main break on Church Street by the Swissvale Presbyterian Church in April. It was repaired and is back in service.

1) The MS4 program will be included in the report starting next month. Necessary documents are in the works that need to be filed by September. Mapping is substantial complete and the borough is participating with Three Rivers Wet Weather to put a mapping system together.

20. Borough Manager Report - Clyde Wilhelm

- 1) New police vehicles were delivered and are in service. Old vehicles will be placed on Municibid in the near future.
- 2) As part of health and wellness initiative, the fire department received a grant from AFG for physical fitness, physicals and vaccinations. HepB vaccinations are being offered to police and DPW employees not as part of the grant.
- 3) Reports coming in from the new delinquent tax collectors are more thorough than our previous ones.
- 4) Mr. Wilhelm investigated the overall current housing situation in the borough.
 - i. Houses that previously sold for \$48-\$77,000 less than 10 years ago are now selling for \$160,000. A house recently sold on McClure Ave for \$5,000 over asking price.
 - ii. Volume of building permits coming in has increased dramatically. The previous average over the last 6 years for the first four months of the year was 25 permits. There have already been 51 permits submitted this year.
